Africa - Supported approximately 1,500 boys and girls through programs managed by the Catholic Diocese of Emdibir in Ethiopia and in Uganda. Assistance included food, clothing, scholarships, lodging, and medical and psychological services.

Asia - Supported approximately 700 boys and girls in the states of Kerala and Gujarat, India, primarily through orphanages, providing essential services such as food, clothing, scholarships, lodging, and medical and psychological assistance.

Latin America - Supported approximately 3,451 children (1,573 boys and 1,878 girls) in 11 institutions across Bolivia, Peru, Colombia, Guatemala, Mexico, and Venezuela. In 2024, emergency grants were also provided to some of the institutions previously supported, in response to urgent needs.

United States - Supported approximately 200 boys and girls through The Village program on Staten Island. Additionally, meals were provided for about 2,713 households as part of the organization's food assistance initiatives.
